To Be Eligible For Competition Into WCHA Sponsored Events Horses MUST First Be Nominated, Horses Must Be Nominated Each And Every Year To Maintain Eligibility.

Weanlings & Yearlings Must Be Sired By Stallions That Is Currently Enrolled In The WCHA Breeder's Futurity Program For 2024.

- \$300 Late nomination payment, after 90 days but prior to December 31st .
- Lifetime Nomination = \$400 If Paid Within 90 Days Of Foaling And Horse Is Nominated For Life

## **Color Nominations For Weanlings:**

An additional nomination fee is required to be eligible for color classes within all WCHA Futurity Programs. All horses with APHA, ApHC, PHBA, ABRA or ARHA registry are eligible for color divisions. Color horses do not have the option to pay only a color nomination, they must first purchase regular nomination and pay color at the same time.

- \$100 Color Nomination Fee if paid within 60 days of foaling date.
- \$200 Color Nomination Fee if paid within 90 days of foaling date.
- \$250 Late Color Nomination after 90 days of foaling date and by December 31st of weanling year.
- Lifetime Color Nomination = \$250 If Paid Within 90 Days Of Foaling Date If Paid With Regular Lifetime.

## **Yearling Nomination Fee Options:**

- \$100 Early Bird Nomination Fee If Paid By March 1st
- \$200 If Paid After March 1st But Prior To May 1st
- \$300 Late Nomination If Paid After May 1<sup>st</sup>
- \$450 "Catch Up Nomination" If A Horse Was Not Nominated As A Weanling, Plus Amount Due For 2024

Yearling Color Nomination Fee Options: To Be Eligible For Color Purses All Horses Must Nominate Each Year.

- \$100 "Early Bird Rate" If Paid By March 1st
- \$200 If Paid After March 1st And Prior To May 1st
- \$250 If Paid After May 1st
- \$300 "Catch Up Nomination" If Horse Was Not Nominated For Color As A Weanling, Plus The Amount Due For 2024 Nomination.
